The Northeast Colorado Child Care Resource and Referral Annual Child Care Providers' conference, "Working Together for Child Care Success," will be held Saturday, April 21 in Yuma at the First Southern Baptist Church from 8 a.m.-5 p.m.

Attendance of this amazing training opportunity is open to anyone in Colorado who wants to learn useful skills in working with children. This includes family child care providers, group leaders, preschool teachers, center/preschool directors, social workers, home visitors, children's librarians, parents, court-ordered child representatives, foster parents, teenage babysitters and all others who are in regular contact with children birth to 12 years old.

Ernie Batson, M.A. who is an early childhood specialist that has been working with children of all abilities between birth and age 8 for over 25 years is going to do the two sessions "Erasing the Battle Lines" and "Little Lab." "Erasing the Battle Lines" is a lighthearted look at recognizing and eliminating power struggles while helping children learn about responsibility. "Little Lab" is a hands-on science workshop that will give great developmentally appropriate classroom ideas for young children.

Tom Westfall, who is an independent consultant, writer and parent educator, will be presenting the session "Caregiving Approaches: A Temperament Focus." This session will focus on helping caregivers identify the temperament style of the children in their care as well as assessing their own temperament and then identify approaches to manage temperament of the children in their care.

The "Grant Writing" session is being provided by Laura Carlson from the Temple Hoyne Buell Foundation. Temple Hoyne Buell funds various early childhood programs in northeast Colorado and throughout the state. Her session will help center and preschool directors to write successful grants.

Clayton Early Learning is sending two of their staff members, Renee McLaughlin and Brenda Hoge, to provide the sessions "Language and Reasoning" and "Making the Most of your Classroom Design." The "Language and Reasoning" session will help child care providers and teachers develop a plan for integrating new language strategies that can help impact children's receptive, expressive and cognitive development.

Teachers will understand how to arrange a classroom that has interest areas with defined quiet, active and transitional centers in the "Making the Most of your Classroom Design" session.


