

## Penalty assessment in place for unlicensed dogs

A series of increasing fines have been agreed upon by City Attorney Al Wall and the judge for dogs found to be unlicensed within Holyoke.

Instead of presenting dog owners with a summons to court, a penalty assessment will be given for first and second offenses, according to Wall at the Tuesday, June 1 City Council meeting.

The new penalty is pretty much the same as the dog-at-large fines. “Hopefully this will get people in compliance,” Wall said. Mayor David Nygaard questioned the option of applying this to other ordinances.

### Citizens present issues

Randy Boyd presented the council with concerns about truck parking in Holyoke. Boyd said he was contacted on a couple occasions by Holyoke police officers about parking his truck on city streets.

Boyd said he has been parking his truck outside city limits for 26 years and occasionally brings it in to connect his air compressor to electricity and he is always empty.

“These are oversights and never the intention of our ordinance to do this,” Nygaard said referring to contacting drivers who are parking for a short period of time.

“We’ve had a lot of confusion in our office to exactly what we’re supposed to allow and what not to allow,” Police Chief Phil Biersdorfer said. He added he will talk with the officers to ensure everyone is clear on the ordinance and clarification is made.
