

## **Proposed wind farm seeking county approval**

Conditional use applications for the proposed Williwaw Goddard Wind Farm were scheduled to be considered at a Phillips County Board of Adjustments hearing Wednesday, Feb. 8, reported commissioners at their Jan. 31 meeting.

The first application is for a 19.8 megawatt wind generation system with 11-12 wind generating towers approximately six miles southwest of Holyoke on the hills known as Fiddler and Goddard Peaks.

The second application is for a 69 kilovolt electrical transmission line to gather the power from the wind farm and take it to the substation on the west side of Holyoke.

After the 7 p.m. hearing held at the courthouse Feb. 8, the Board of Adjustments will give their approval, approval with conditions or denial to the applications and then take their recommendation to the commissioners for their approval.

## **Kinnie now chairman of commissioner board**

After a reorganization meeting in January, commissioner Joe Kinnie is now chairman of the board, while commissioners Bud Bieseimeier and Jerry Beavers will serve as co-chairmen.

In last week's meeting, commissioners announced Holyoke is planning to build an all-weather track, including new lighting, at a preliminary project total of over \$500,000. The school is not eligible to apply for grant funds from Great Outdoors Colorado (GOCO), so Phillips County will work with them to make the application for the \$350,000 grant.

WENS (Wireless Emergency Notification Systems) to replace the paging system for emergency personnel and law enforcement.

This year's Taste of Agriculture was a success, said commissioners, with everyone giving very positive comments about the event. There were around 300-350 people in attendance with around 45 vendors giving a taste of their goods.

The Amherst fire hall was purchased for District 1 for \$18,000. It will serve as an extension to their shop as well as a place to store equipment.
